

**FEDERAL DIRECT PLUS LOAN INFORMATION FORM**
**PARENT BORROWER:**

- This form is intended to collect information for **one** parent only. Submit a separate form for each additional applicant. The parent borrower must request the PLUS loan each year by completing a new Federal Direct PLUS Loan Information Form.
- Complete the form in its **entirety**. Incomplete forms will delay processing and disbursement of funds. Clearly type or print all information.

**SECTION 2**

- Loan Period** – Describes the terms of enrollment in which you would like the loan for. Example: “Fall 2009” – The loan will be disbursed in the fall. Therefore, only fall charges will be covered.
- Loan Amount Requested** – When determining the amount of your loan request, please keep in mind that you must apply for sufficient funds to cover both the Fall and Spring University Fee Bill. This amount cannot exceed the PLUS Loan eligibility indicated in your student’s Financial Aid Award Package.
- IMPORTANT - Effective this year, the University participates exclusively in the Federal Direct Loan Program, in which parents borrow directly from the Department of Education. All 2009-2010 Federal Direct PLUS Loan borrowers will need to complete a new MPN. You will be sent further instructions on completing the MPN if your loan is credit approved.**
